- Products are intended for professional evaluation and not for resale.

- All formulations, technical specifications, and related documentation are the property of Laboratorium DermaPharm Sp. z o.o..
- Participants agree not to disclose product details or confidential information to unauthorised parties without prior written consent.

## **6. Use of Feedback**

- By participating, you grant Laboratorium DermaPharm Sp. z o.o. the right to use your anonymised feedback, comments, and case results in marketing, product literature, and internal reports.
- Any public attribution (e.g., quoting your name or clinic) will require your written consent.

- Participants are responsible for ensuring products are stored, handled, and applied in accordance with guidelines.
